DEFINITIONS

“Us” or “We” or “Our” means P.E. Department, its staff, directors, officers or agents. “You” or “Your” means the member.

P.E. 1 Week Pass – Terms & Conditions

1. You agree and acknowledge that the P.E. 1 Week Pass is a paid promotional membership, and that all membership Terms and Conditions detailed in this document apply.
2. You agree and acknowledge that the \$40 fee for the 1 Week Pass is payable upfront and is non-refundable, subject to the terms outlined below.
3. You agree and acknowledge that failure to notify us of your intention not to continue with a membership by submitting a completed cancellation form in accordance with our procedures prior to the expiry of the 1 Week Pass will result in the 1 Week Pass automatically rolling over into an ongoing membership.
4. You agree and acknowledge that if you do not specify a membership option prior to the completion of your 1 Week Pass, our team may allocate a suitable membership option based on your utilisation of the club during the promotional period.
5. You agree and acknowledge that the \$40 paid for the 1 Week Pass will be applied as a credit toward your membership fees only if you convert to an ongoing membership immediately following the conclusion of the 1 Week Pass.
6. You further agree and acknowledge that if you roll over onto a membership after the completion of the 1 Week Pass and subsequently provide 14 days' notice of cancellation, the \$40 1 Week Pass credit will be forfeited and will not be refunded, reapplied, or credited toward any outstanding or future fees.
7. You agree and acknowledge that the 1 Week Pass is not intended for short-term usage. Individuals visiting Sydney for short stays, including stays of one or two weeks, do not qualify for this promotional pass.

8. You agree and acknowledge that to qualify for the 1 Week Pass, you must have a registered residential address in Sydney, verified payment details, and provide any additional proof of residency reasonably requested by us.
9. You agree and acknowledge that temporary addresses, including but not limited to hostels, hotels, serviced apartments, and AirBnB accommodations, do not constitute a registered residential address and do not meet eligibility requirements.
10. You agree and acknowledge that if you purchase the 1 Week Pass online and are later found not to meet the eligibility requirements, the \$40 payment will be allocated toward an alternative short-term membership option offered by us. No refunds will be provided in this circumstance.
11. You agree and acknowledge that to cancel your 1 Week Pass or prevent rollover into a membership, you must follow all cancellation procedures outlined in this document.
12. You agree and acknowledge that if a complimentary or discounted period is granted in conjunction with or following the 1 Week Pass, you commit to a paid membership period equal to or greater than the complimentary or discounted duration immediately following that period.
13. You agree and acknowledge that this commitment is binding and forms part of the membership agreement. If you fail to commence the agreed paid membership, we reserve the right to charge retroactively for the equivalent value of the complimentary or discounted period.
14. You agree and acknowledge that any freeze period taken during a discounted or promotional membership will count toward the total duration of the promotional period. Freeze periods do not pause, extend, or otherwise lengthen the number of discounted or promotional days available.
